Zoning Committee Data Sub-Committee Meeting Minutes Thursday April 21, 2016, 10 AM

Blue Book Capacity Data

Dan Katz compared Blue Book capacity numbers for all District 3 schools (see spreadsheet on last page). The goal was to understand target capacity changes from 2013/14 to 2014/15 Blue Book report by the School Construction Authority and whether the information can be helpful to upcoming zoning exercise. However these data points may not be useful at all because site visits have not been conducted at all of the schools where significant changes are listed. In addition, the SCA has not explained as significant changes at several schools.

In addition, current school enrollment and capacity do not reflect demand; nor does this information reflect any other school or solutions (programming or otherwise) that may affect zoning.

To that end, data subcommittee generated a list of other data points needed at this time:

1. Updated real estate spreadsheet for ps191 and 199 (Angeline to work on)
2. Detail about Riverside Center residential units and occupancy dates.
3. KC application numbers for all potentially affected schools, broken down by admissions priority, for the current year and previous two years

We listed 3 priorities for zoning exercise:

1. Decrease kindergarten class number to 5 at ps199 to alleviate overcrowding
2. Increase to kindergarten capacity at PS191 and PS452
3. Provide for increased diversity at affected schools; to this end, equitably distribute students from NYCHA Amsterdam
4. Consider possible solutions for severely under-enrolled schools in the northern part of the district.
5. Continue pathway to re-siting PS191 to new building and consider possible solutions for old PS191 building.

Over the next few weeks, the data and solutions subcommittees will continue to work with the Superintendent, Office of District Planning and other stakeholders to prepare for a full committee meeting. To this end, the Thursday May 5th meeting was moved to Monday, May 23rd in order for all parties for be prepared for the next steps in the official zoning exercise. An alert for this meeting will be sent out separately, and see below for Blue Book spreadsheet.
