# Discussion

What is poaching? Several comments regarding recruiting families into DL programs from out of zone or out of district. Principals have unwritten rule they won't proactively poach students from other schools, which is different from when an out of zone/out of district parent, on their own, choses to come and enroll at a school.

Dr. Dariusz Zawislak (CCELL) – interested in advocating for Polish and Japanese to be permanent translation languages. Undercounting of Polish students. CCELL and DOE checking on ELL data and how Enrollment form captures home language information.
