Goals for 2025-26

DISTRICT 3 DCEP Goals



Priority 1: All students learn to read well.

- **By June 2026, 72% of District 3 students in grades K-2 will demonstrate “typical or better progress on Acadience Reading.” (5% increase)**
- **By June 2026, 60% of District 3 students in grades 3-8 will demonstrate “typical or better progress on iReady reading screener.” (8% increase)**
- **By June 2026, 50% of District 3 elementary and middle school students in grades 3-8 will meet English Language Proficiency Progress as measured by the New York State English Language Achievement Test (NYSESLAT).**

DISTRICT 3 DCEP Goals



Priority 2: All students are physically and emotionally safe.

- By June 2026, the number of reported Level 4 + Level 5 incidents in OSYD will be reduced to 570.
- By June 2026, 85% of D3 schools will have SEL programs selected and implemented consistently across classrooms which will lead to an increase of 5% for the Panorama survey question: “The school works to develop norms that can proactively support student learning, setting high standards for students, encouraging supportive peer norms, and providing strong guidance.” from 61% TO 66%.

DISTRICT 3 DCEP Goals



Priority 3: All students have a high-quality academic experience.

- By June 2026, the percentage of middle school students demonstrating proficiency on the Algebra 1 Regents exam will increase from the current baseline of 72% to 77%, as measured by the NYS Algebra 1 Regents examination.
- By June 2026, the percentage of K-12 students demonstrating proficiency on i-Ready Math assessments will increase from the current baseline of 50.2% to 65%.

DISTRICT 3 DCEP Goals



Priority 4: All students graduate college and career ready and have a strong plan and pathway to economic security.

- **By June 2026, 96% of students in the district will be enrolled in an advanced course.**
- **By June 2026, 28 schools in the district will have participated in the Civics For All program, implementing Civics and Soapbox lessons across one grade level.**
- **By June 2026, 77% of 8th graders will pass the Algebra Regents.**

DISTRICT 3 DCEP Goals



Priority 5: All districts and schools are more inclusive and responsive for parents and families, including having more families choose NYC Public Schools.

- By June 2026 the satisfaction rate of the parents of Black students in District 3 will increase by 10% in the area of Family Satisfaction with Child's Education on the 2026 NYCPS School Survey when compared to 2025 survey data.
- By June 2026 the satisfaction rate of the parents of American Indian students will increase by 10% in the area of Parent Involvement in School on the 2026 NYCPS School Survey when compared to 2025 survey data.
- By June 2026 the satisfaction rate of the parents of students with IEPs will increase by 15% in the area of Building Families' Capacity as their Child's Primary Advocate on the NYCPS School Survey when compared to 2025 survey data.
- By June 2026 the satisfaction rate of the parents of STH students will increase by 12% in the area of Building Families' Capacity as their Child's Primary Teacher on the NYCPS School Survey when compared to 2025 survey data.
